

The Partnership for Action on Green Economy (PAGE) is a 7-year programme launched in response to the appeal made at Rio+20 for the UN system to support countries interested in pursuing the transition to a green economy within the context of sustainable development and poverty eradication. It uses the joint expertise of UN agencies – UNEP, ILO, UNIDO, UNITAR, UNDP and others – to progressively assist a total of 30 countries in their efforts to transition to environmentally viable and socially inclusive economies.

PAGE seeks to create enabling conditions in participating countries by: identifying critical bottlenecks, assessing investment options and formulating policies to encourage the creation of a new generation of assets such as clean technologies, resource-efficient infrastructure, well-functioning ecosystems, green skilled labour, job-rich growth, and good governance.

#### The ILO Turin Centre's facilities

Located in an attractive park on the banks of the River Po, the Centre's campus provides a congenial environment in which to live and study.

• It contains 21 pavilions with fully equipped modern classrooms, conference halls and meeting rooms fitted out for multilingual simultaneous interpretation, and a computerized documentation centre linked to various data banks.

The campus has 185 single fully serviced study/bedrooms, 66 double bedrooms and 12 suites, each with private bathroom, telephone, wi-fi and flat screen television (satellite-TV available in the majority of the rooms). Among those bedrooms, 22 rooms are accessible for people with disabilities.

It also has:

- a reception desk open 24 hours a day;
- a restaurant, a self-service canteen and a coffee lounge, all catering for international dietary needs;
- a bank;
- a travel agency;
- a laundry service;
- a post office;
- an internet point;
- a recreation room;
- facilities for outdoor and indoor sports;
- medical service.

Social events are regularly held both on and off campus, so that participants from different cultural backgrounds can make the most of a stimulating international environment.

# Academy on the Green Economy

The adoption of the 2030 Agenda for Sustainable Development and the Paris Agreement on climate change propelled sustainability in its three dimensions at the fore of the international development agenda, laying the foundations for systemic changes in the way economies and societies function. The new global policy landscape and the initiatives by countries to shape their national strategies needs to be facilitated by a strong an up-to-date knowledge base for greener and low-carbon economies in the wake of the Sustainable Development Goals

This 2-week training and learning event aims to solidify current knowledge and foster an exchange of practices in the transition to environmentally sustainable and socially inclusive economies. Participants will increase their capacity to formulate and implement green economy policies and strategies at national level and in key economic sectors, keeping up with new orientations of markets, government policies and social aspirations.

Following the <u>successful implementation of its first</u> <u>edition in 2014</u>, and building on results achieved through national and regional activities of the Partnership for Action on Green Economy (PAGE) over the past two years, this second edition of the Green Economy Academy will boost delivery and knowledge sharing across countries and organisations involved.

Hosted by the ILO International Training Centre (ITCILO) in Turin, Italy, and organized within the framework of PAGE, this Academy brings together technical expertise and practical experience from each of the PAGE partners and countries, as well as from collaborating networks and institutions, such as the Green Economy Coalition (GEC), the International Renewable Energy Agency (IRENA) and the Green Growth Knowledge Platform (GGKP).

# **Learning Objectives**

By attending the Academy, participants will have an increased capacity to identify and build on opportunities for the promotion of a socially inclusive green economy. They will have gained in-depth understanding of suitable approaches, tested tools and best practices for interventions in key economic sectors that will contribute to achieving long term impacts in the framework of national sustainable development strategies.

## **Target group**

- Policy makers, technical staff and stakeholders from civil society organizations, trade unions, employers' organizations, cooperatives, knowledge and research institutions, in current PAGE countries;
- Delegates from other interested countries which are adopting green economy strategies;
- Staff and practitioners from partner/interested agencies and donors.

#### Content

The Academy will be structured around PAGE's approach in supporting the formulation, adoption and implementation of inclusive green economy policies and strategies. In complementarity to PAGE's national institutional capacity building strategies, this event, with global outreach, will also focus on the sharing of practices at all levels – national, policy, sectoral, value chain and enterprise – in order to offer participants fact-based learning.

Topics include: green economy as a means for poverty reduction and social inclusion in the framework of the 2030 Agenda for Sustainable Development; quantitative modelling options for green jobs assessment; the interplay between climate change strategies and green economy policy options; greening industries and green enterprise promotion; economic diversification, decent work opportunities and gender equality in the transition to low-carbon and climate-resilient development; priority sectors of intervention, such as sustainable agriculture, energy transition, waste management, sustainable forestry management, green buildings and infrastructure development.

# Methodology

The faculty, representative of the collective experience of PAGE partners, national stakeholders and collaborating agencies, will consist of: national PAGE coordinators, international experts, trainers, practitioners and policy-makers from different regions. The learning approach used by the ITCILO seeks to develop human resources and institutional capabilities, by encouraging participants to:

- Customize their learning experience according to their individual and organizational needs;
- Share knowledge and experience with a large international community of practitioners;
- Establish networks with other national, regional or global organizations and centres of excellence.

### High-Level Policy Dialogue: The Future of Work in a Greener Economy

On **3 October 2016** a High-Level Policy Dialogue, inaugurating the 2nd global Academy on the Green Economy, will focus on job creation and social inclusion in the context of climate change and resource scarcity. The goal is to converge on an ambitious policy agenda for green economy promotion that turns these global challenges into dynamic forces that deliver positive labour and social outcomes. The context for this discussion is the <u>ILO's Future of Work Initiative</u> and the recently adopted <u>ILO Guidelines for a Just Transition</u>.

By specifically inviting high-level government officials, donor representatives, investors, civil society organisations, and staff from partnering agencies, the High-Level Policy Dialogue will contribute to the identification of policy instruments and practical tools that help countries at all levels of development manage the transition to low-carbon and climate-resilient economies, in line with their Nationally Determined Contributions (NDCs) and the SDGs.
