Title: Prioritize Nature-based solutions in infrastructure

Focus area 3: Enhance ecosystems and ecosystem services as part of ecological infrastructure.

Description of the action: Within the framework of the national project "Green Kazakhstan", in order to achieve the Task of preserving the ecosystems of the country's water bodies, an inflow into Lake Balkhash of at least 12 km3/year will be planned. It is also planned to increase the volume of the Northern Aral Sea by 35% (from 20 to 27 km3). Four lakes (Kopa, Borovoe, Shchuchye and Shalkar) will be cleaned and restored. Measures have been taken to reduce the volume of fresh water intake in industry by 1.3 km. For additional accumulation of water with a volume of 1.7 km3, 9 reservoirs will be built.

It is planned to increase the country's forest cover up to 5% by 2025 by planting 2 billion trees.

В рамках национального проекта «Зеленый Казахстан» для достижения Задачи по сохранению экосистем водных объектов страны планируется обеспечен приток в озеро Балхаш не менее 12 км3/год. Также планируется увеличение объема Северного Аральского моря на 35 % (с 20 до 27 км3). Будет проведена очистка и восстановление четырех озер (Копа, Боровое, Щучье и Шалкар). Проведены мероприятия по снижению объема забора свежей воды в промышленности на 1,3 км. Для дополнительного аккумулирования воды объемом 1,7 км3 будут построены 9 водохранилищ.

Увеличение лесистости страны до 5% к 2025 году планируется достигнуть за счет посадки 2 млрд. деревьев.
