1.1. Overview

This document, developed by the Green Growth Knowledge Partnership (GGKP) under Component 4 of the Global Environment Facility (GEF) ID 10785 project, *Global Development, Review and Update of National Implementation Plans (NIPs) under the Stockholm Convention (SC) on Persistent Organic Pollutants (POPs)*, serves as a guide for participating countries to navigate the system of knowledge management and information sharing of the project.

Figure 1. Global NIP Update knowledge management structure

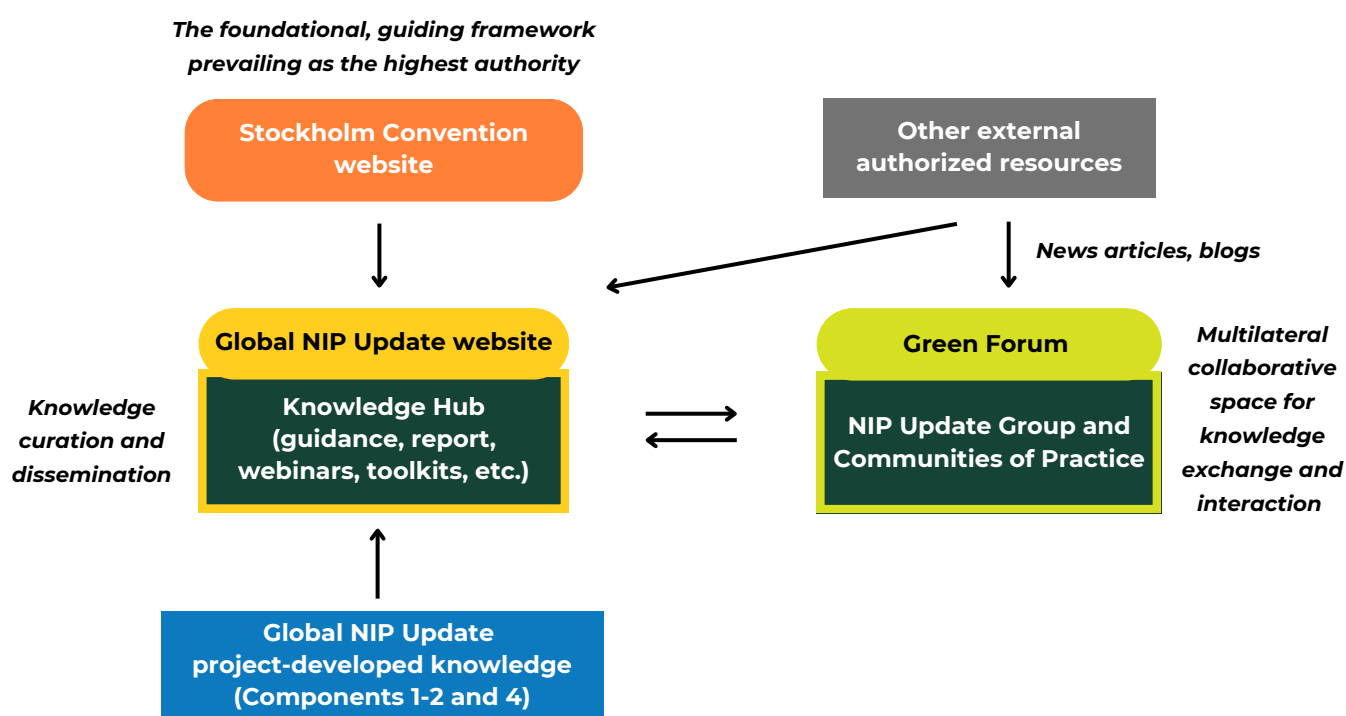


Figure 1 shows the Global NIP Update project's knowledge management structure. The **Stockholm Convention** (SC) serves as the primary guiding framework, providing the highest authority for Parties developing their NIPs. Project countries can access the [SC website](#) for information on POPs and NIPs developed by the Secretariat of the Basel, Rotterdam and Stockholm conventions (BRS Secretariat). The main knowledge-sharing platform of the GEF 10785 project is the [Global NIP Update website](#).

This platform is designed to share and disseminate project-related information, deliverables, and knowledge with participating countries, ensuring user-friendly access to all necessary and curated knowledge resources. It complements SC resources by addressing country-specific challenges and integrating authorized external insights to enhance NIP implementation. Stakeholders can find project updates, NIP development resources and best practices, making it a vital tool for supporting countries to update their NIPs and meet their obligations under Article 7 of the Stockholm Convention.

The **Green Forum** is a virtual multilateral platform designed to facilitate knowledge exchange and interaction among project stakeholders. Its primary goal is to enhance information sharing and peer learning, enabling all stakeholders to share updates, ask questions and communicate effectively. Content shared on the Green Forum ranges from news articles and blogs to webinar summaries and publications. Members can contribute their knowledge and experiences and share opinions using the comment function, fostering collaborative knowledge-building.

The [Development, Review and Update of National Implementation Plans \(NIPs\) on Persistent Organic Pollutants \(POPs\)](#) Group – referred to as the **NIP Update Group** – serves as a global community for NIP practitioners and experts. Open to the public, this group provides a space to connect with stakeholders, share opportunities and events, and disseminate valuable knowledge. The group enables project stakeholders to create subgroups called “communities”, which project countries and/or regional executing agencies can use as a public or private space for internal coordination purposes, or targeted dissemination and outreach efforts.

1.2. What is the GGKP?

The Green Growth Knowledge Partnership (GGKP) is a global network of organizations and experts that aim to identify and fill knowledge gaps in green growth theory and practice. As a knowledge broker, the GGKP facilitates knowledge exchange and collaboration to accelerate the global transition towards an inclusive green economy. It empowers stakeholders with actionable insights, bridging research and practice to drive environmental sustainability and green economic development worldwide.

Figure 2. GGKP steering committee and platforms



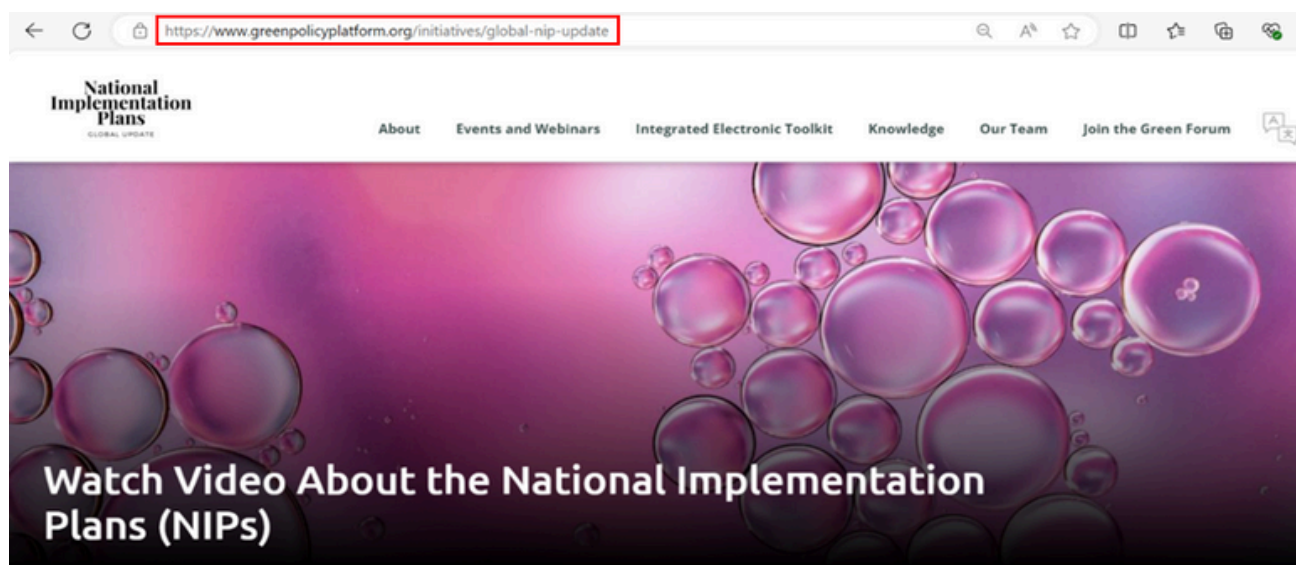

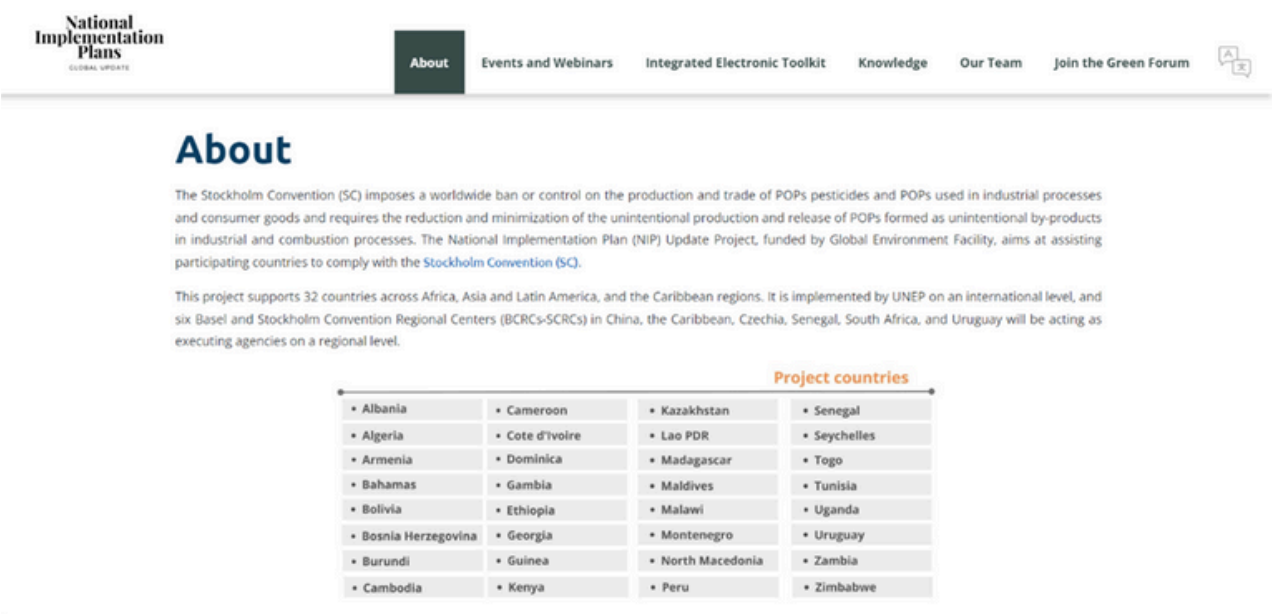


2.1. How to navigate the website

Through the navigation tabs at the top of the page, users can easily access different sections of the website as specified below.

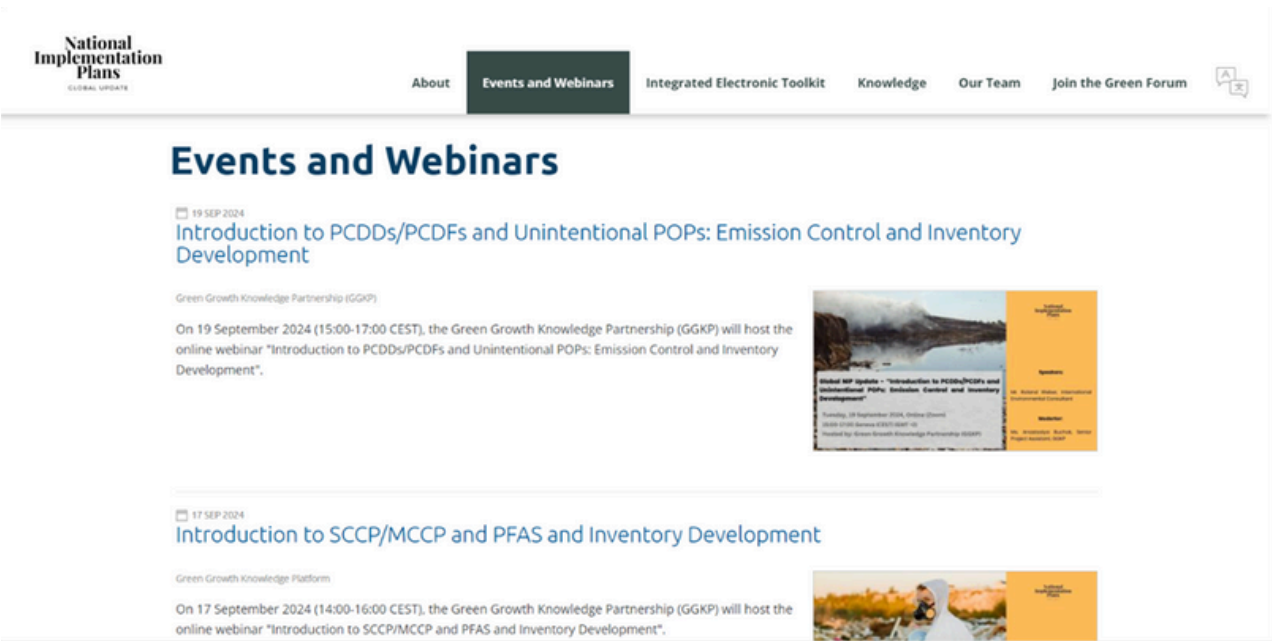
2.2.1. About

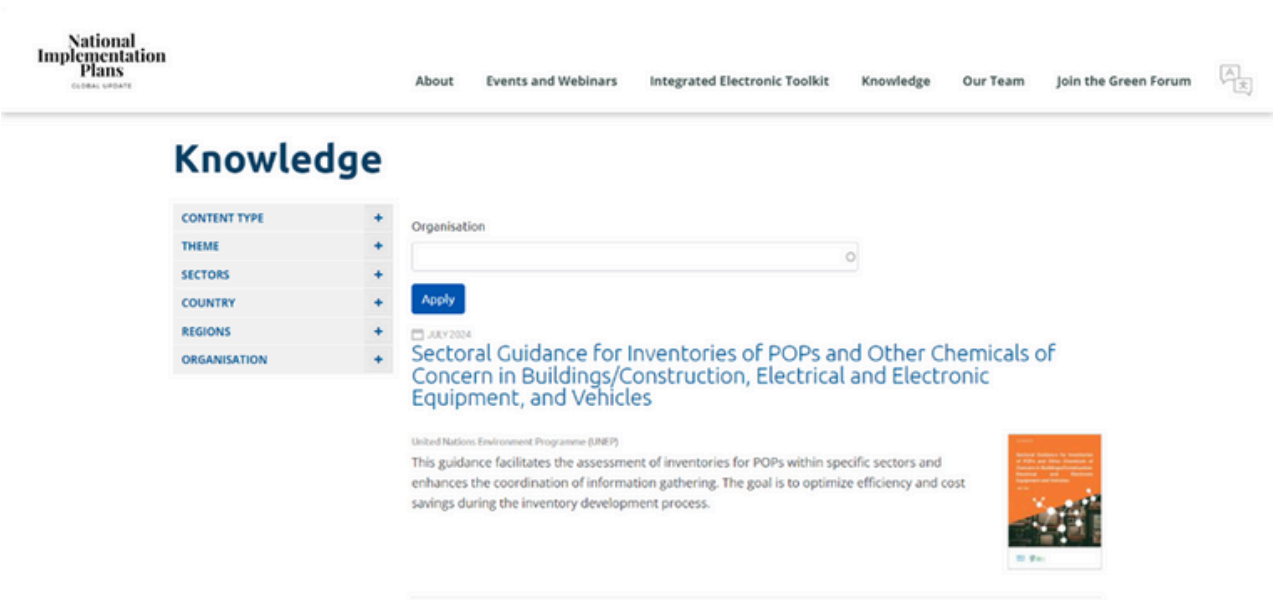

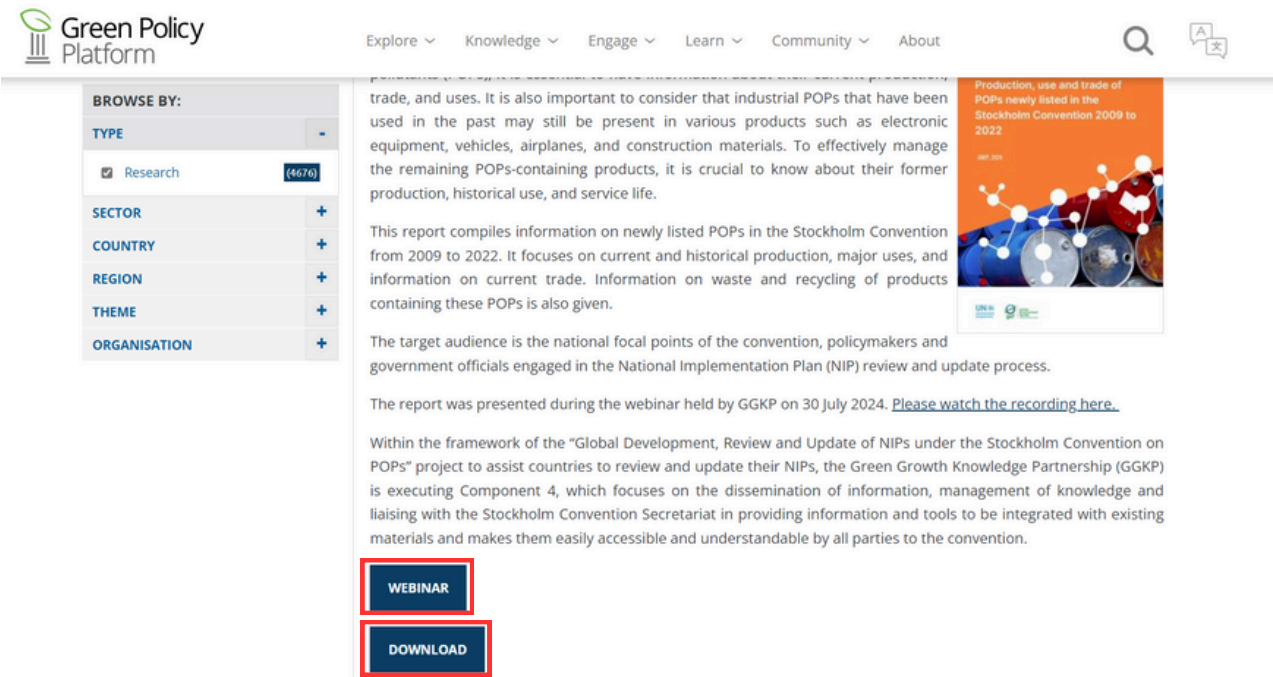

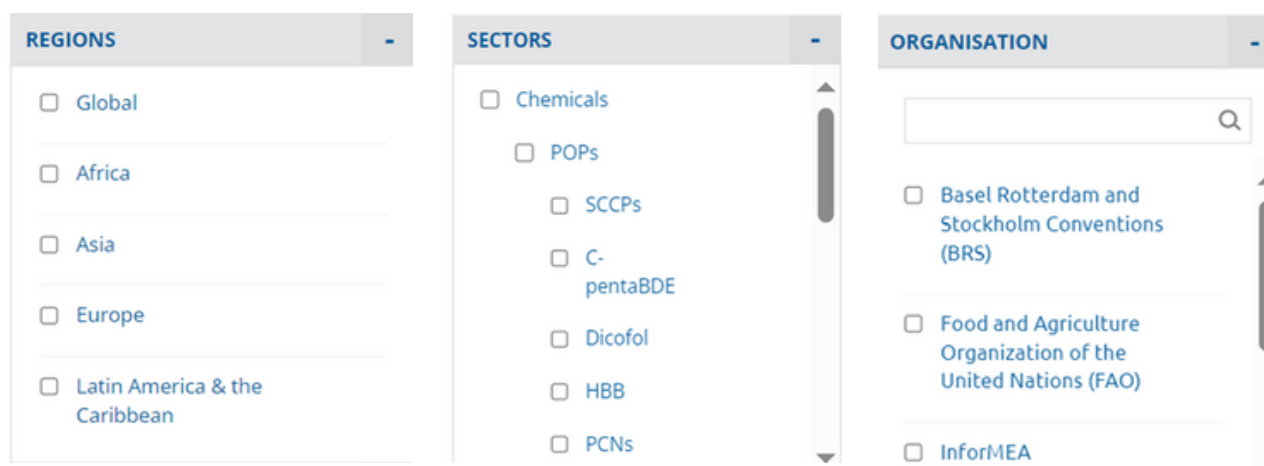

2.3. Additional features

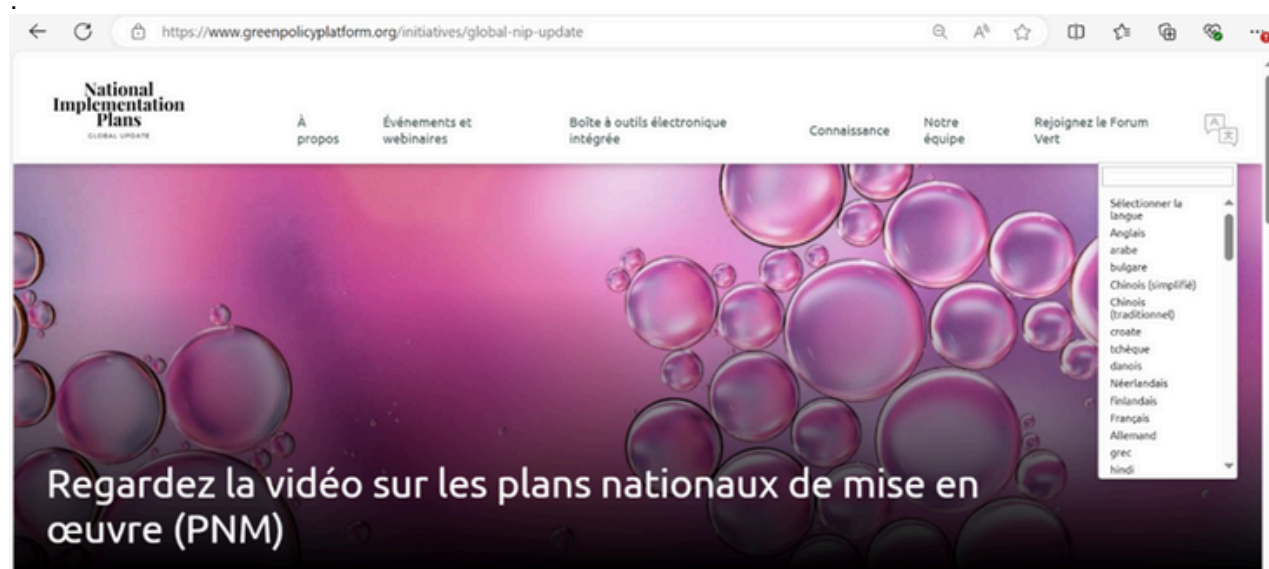
2.3.1. Knowledge filter

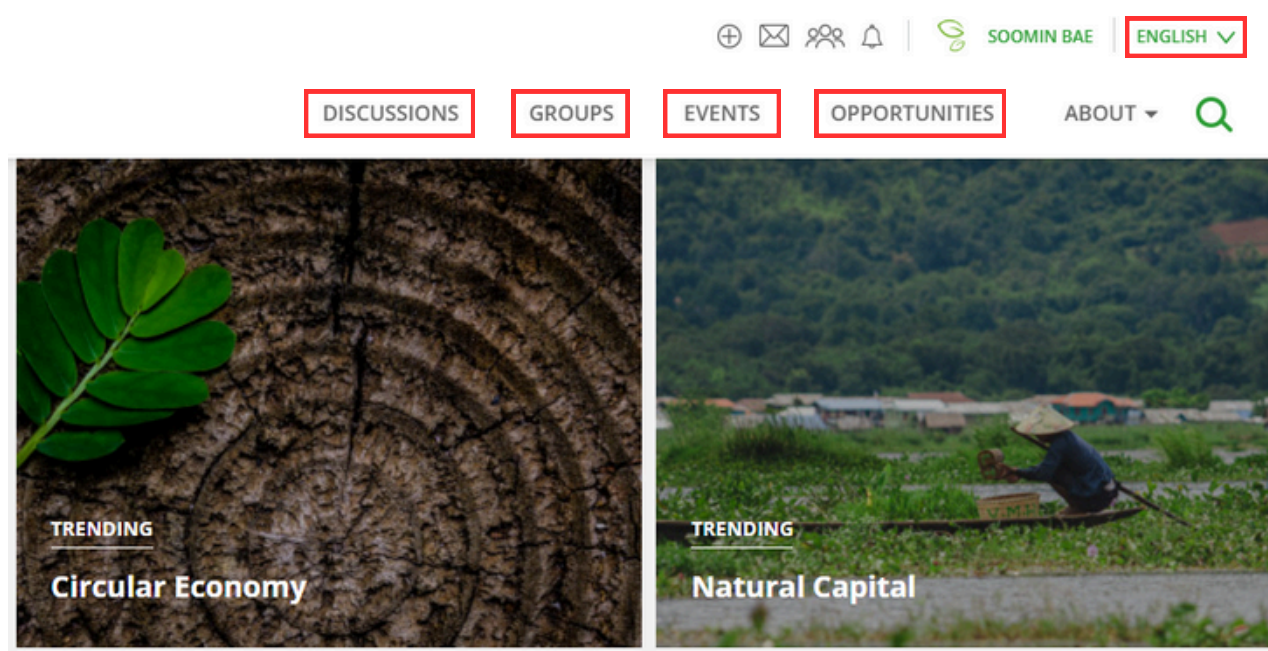


3.2. Green Forum functionality

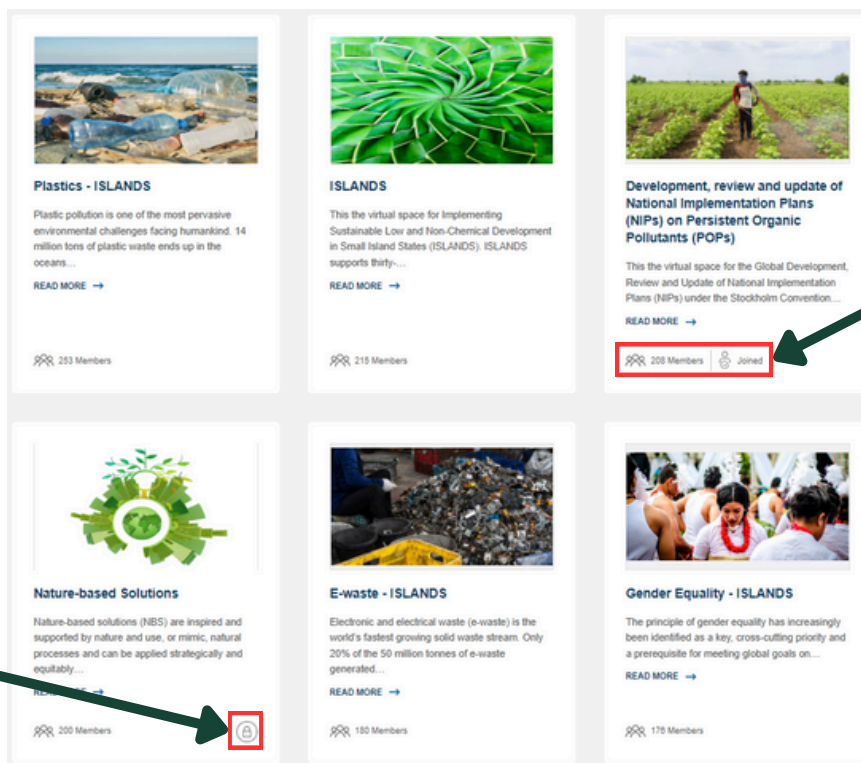

 - Any member can create an opportunity. These are generally calls for applications and papers or jobs. All *public* opportunities can be found on this page.

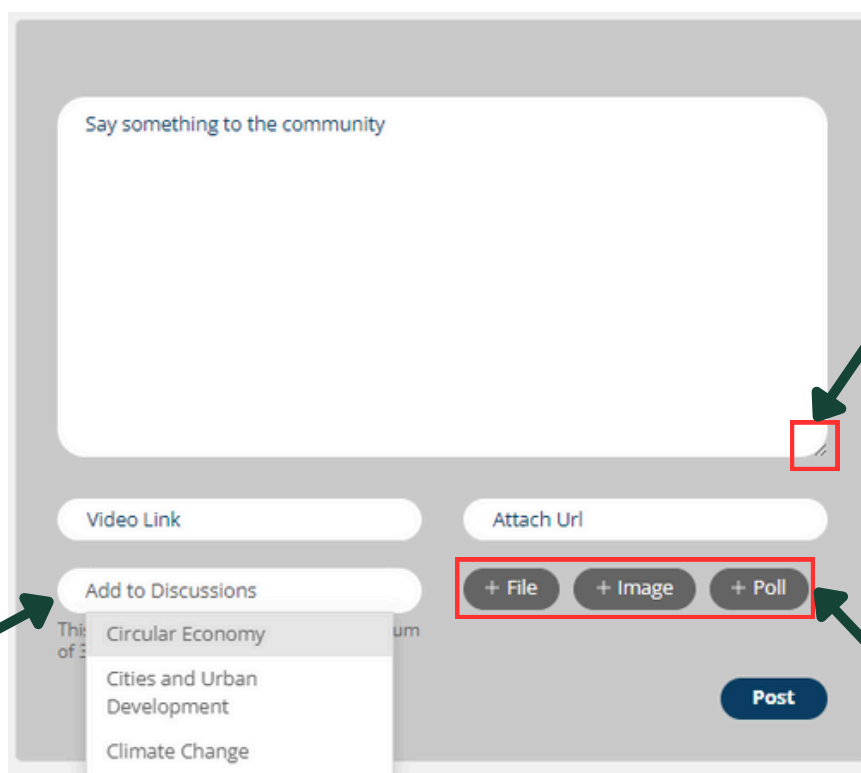

You can create a post from either the homepage or within discussions and groups. It can include video links, URL, files, images and polls.

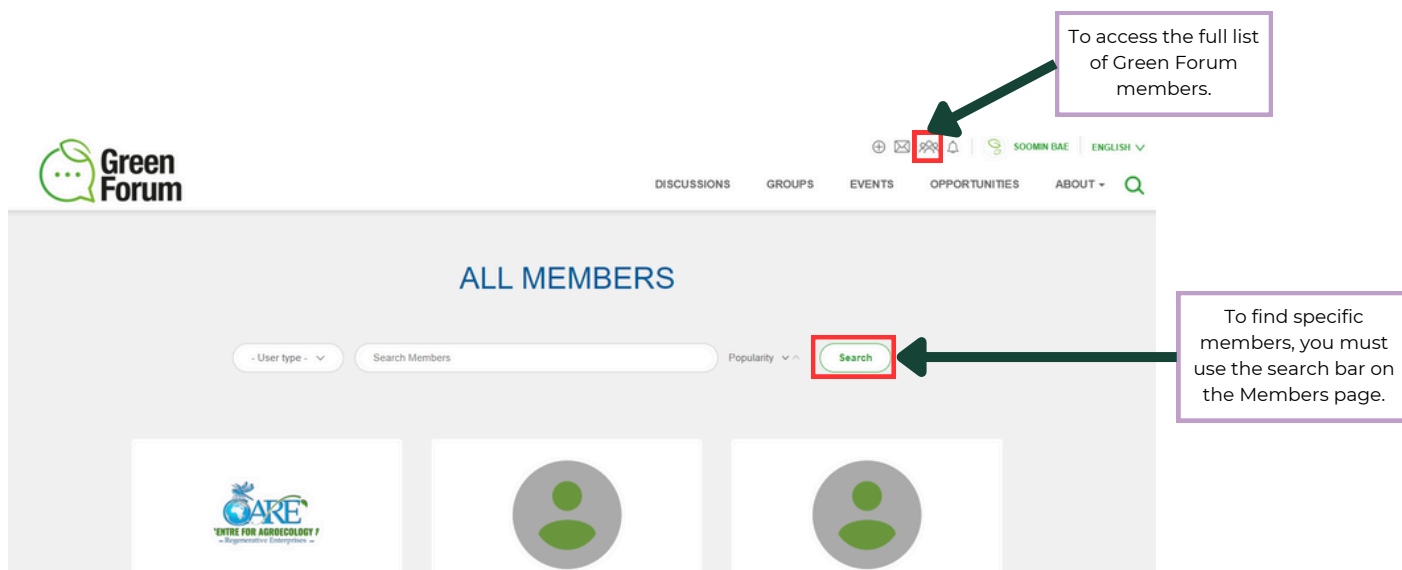


Drag this to expand or shrink the size of the window.

You can include a file, image, or poll in a post.

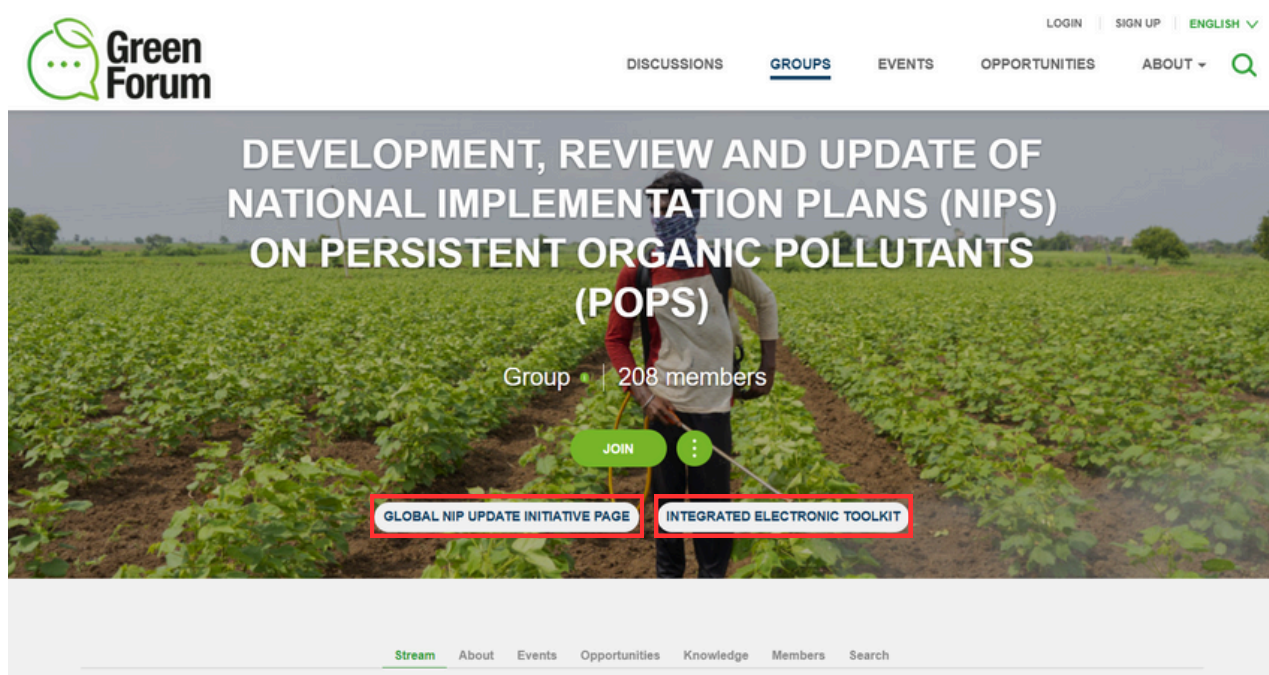

3.3. NIP Update Group and communities

The [NIP Update Group](#) serves as both a public and private platform for engaging stakeholders on topics related to POPs and NIPs.

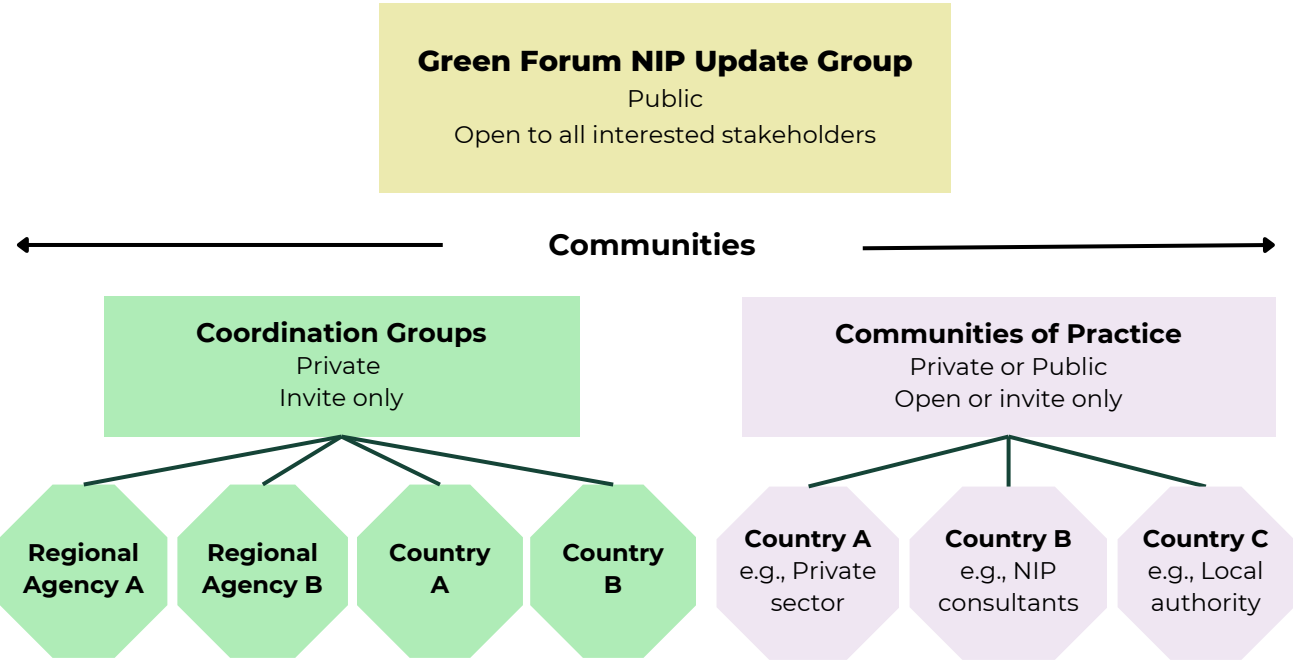
- **Public:** Open to all, this platform allows all interested parties to stay informed about webinars, events and opportunities within the project. Knowledge resources, blogs and posts shared in this space are accessible to anyone online, fostering broader engagement.
- **Private:** Designed for internal collaboration, this space can be utilized to facilitate discussions on the NIP coordination process, internal updates and targeted outreach efforts. It serves as a dedicated area for sharing information with specific stakeholders.



3.3.1 Structure

The global **NIP Update Group** is a public space, and any interested party can join and participate in the group. Within the global NIP Update Group, **communities**, or subgroups can be created and managed by project countries or regional executing agencies and further tailored to respective audiences. NIP Update communities can be created for the following purposes: **NIP Coordination Groups** and **Communities of Practice** (Figure 3).

3.3.2 NIP Update Group

The overall NIP Update Group is the global community of NIP practitioners and experts. This group is open to the public and serves as a space to connect with POPs experts and project stakeholders, share relevant opportunities and events, and disseminate knowledge. Users can easily navigate to other Global NIP Update digital toolkits and platforms from the main page of group.

Events, opportunities, blogs and knowledge products can all be uploaded on the Green Forum. Anything uploaded within the overarching NIP Update Group will be accessible to anyone disregarding their membership on Green Forum. The steps for uploading an event, opportunity, blog, or knowledge product are similar. Key elements to consider are highlighted below.

• Events

- Share details of upcoming **events and webinars** related to POPs and NIPs. Past events are also available for reference.

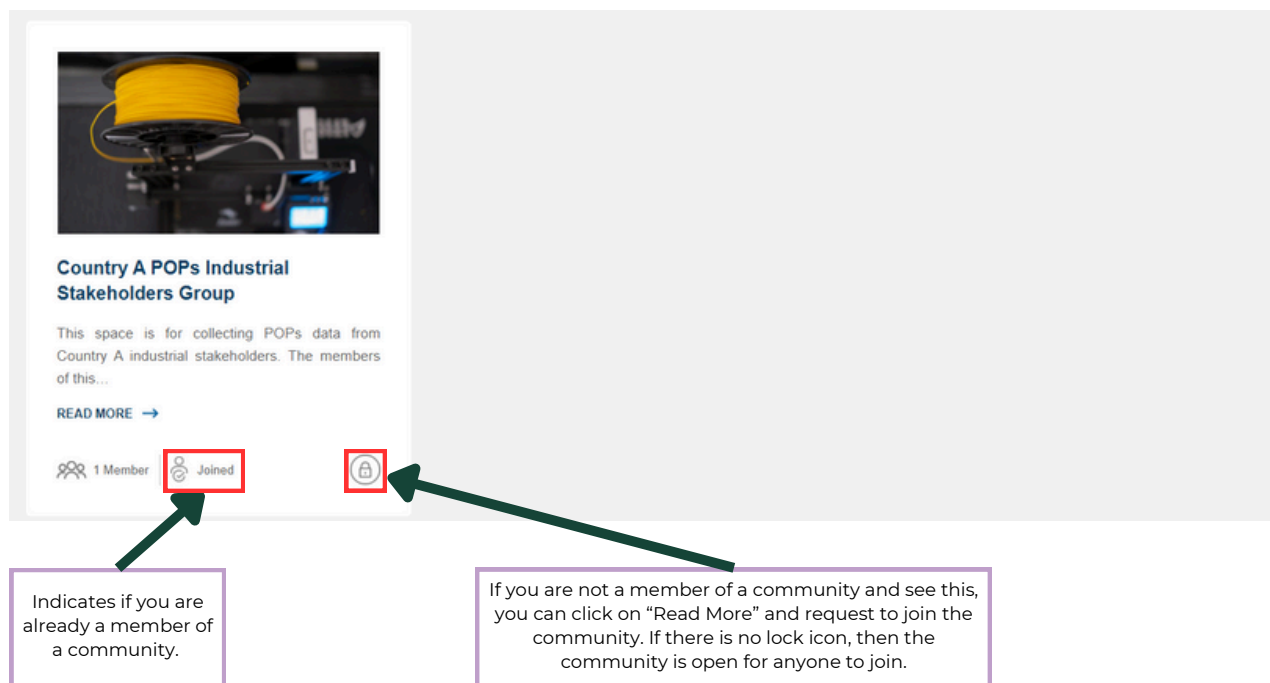
• Knowledge products

- Upload guidance, research, learning materials and project documents.
- Ensure the “Knowledge date” reflects the original publication date, not the upload date.
- Include all relevant organizations under “Publisher(s)” and add new ones if needed.

3.3.3. Coordination groups and communities of practice

Coordination groups and communities of practice are designed to be led by individual countries or regional executing agencies. They can request GGKP to create a community within the Green Forum NIP Update Group and manage it independently, making it available for the stakeholders of their choice. Communities can serve various purposes, such as collecting data from the private sector, communicating current NIP progress to consultants or local authorities, and sharing or archiving new knowledge and NIP-related events. Managers/owners of the communities of practice can tailor the community to the specific engagement activities expected from the target audiences. They can also determine whether their community will be private or public based on their objectives. Materials shared within private groups are restricted to invited members only and are not visible to the public.



When countries are creating a community, the following steps should be followed:

1. Define the type of community (private/public) and identify stakeholders to include, such as National Coordinating Mechanisms (NCMs), private sector representatives, academia, civil society, and/or press, etc.
2. Submit an email request to GGKP (anastasiya.buchok@ggkp.org; soomin.bae@ggkp.org or stephani.widorini@ggkp.org) to create a private or public group for these stakeholders. GGKP will also provide training to ensure effective group management.
3. Upon request, GGKP can suggest and review engagement activities to help the community interact with its stakeholders and keep them updated.
4. Assign a manager to oversee and maintain the group's activities.
5. Conduct regular outreach activities. Maintain consistent communication with stakeholders by sharing:
 - Updates under the Stockholm Convention
 - New resources about POPs and NIPs
 - Changes in national regulations
 - Capacity-building events
 - Regular newsletters and other relevant materials
 - Other information tailored to the needs and nature of engagement of community stakeholders

These are the options that users need to decide when creating a community in the NIP Update Group. The bolded text indicates required actions and the **green bolded text** presents recommended actions for communities of practices. Members who want to create a community should provide information on these options to the GGKP team.

Anything added to a “Secret Group” or a “Flexible Group” with its visibility set to “Group members” will remain hidden from those outside of the community. In a “Flexible Group”, any event, opportunity, knowledge product, or blog can be set to *public* upon creation, allowing them to be shared with a broader audience.
