

## **Global NIP Update Workshop**

**“Outreach and Engagement with Major Stakeholder groups for Developing National Implementation Plans.”, August 13, 2024, at 10:00 –11:05 CEST, GMT+2**

This is the first event in the series of workshops held by the Green Growth Knowledge Partnership (GGKP) within the framework of Component 4 (Knowledge management and information sharing) to provide assistance in developing country’s strategy on outreach and information dissemination as part of their efforts to update the National Implementation Plans and meeting their obligations under the Stockholm Convention

### **Introduction**

Structure of NIPs provides the need for a detailed POPs inventory, which serves a prerequisite to an action plan and is a compilation of information on past and present production and uses of a chemical listed in the Stockholm Convention on POPs in the country. As many POPs are used in the manufacture of products/articles which may have a long service-life, a comprehensive inventory should also estimate the amount of POP in the products/articles in the country (e.g. in buildings or used by consumers) along the whole life cycle, thus contributing to the provisions of Article 6 of the Convention on management of waste.

Preparing an inventory that gives a full picture of a POP use in a country requires use of various sources and data collection methods, whereas data collection exercise assumes efficient outreach to relevant groups of different stakeholders, their cooperation and involvement in the inventory process, as well as further consistent communication with the government bodies within the framework of Stockholm Convention.

There is a need for tools to support Parties in conducting outreach and consultation with stakeholders, especially the private sector as users of POPs, to ensure their participation in the management of POPs. Provision of specific guidance and assistance for dissemination, outreach, and private sector engagement, as well as a compilation of examples of knowledge management and information-sharing strategies for regional and national priorities, are of great importance. This workshop is aimed at providing input to the aforementioned guidance provision.

## **Format**

The workshop will be conducted virtually through an online Zoom platform. It will consist of five short sessions mainly for interactive discussions with prepared list of questions and knowledge-sharing opportunities. The workshop discussion will feed into the strategy document compiled by the GGKP that can be customized by Parties. Workshop materials and resources, together with recorded videos of the webinar will be made available for participants to access and refer to after the event through the [knowledge platform](#) and the NIPs community space.

## **Objectives**

1. Consultation with the project countries: receive inputs from country's perspectives and gather information relevant to their national context in terms of mapping and facilitating engagement with stakeholders to get involved for accurate data collection and development of NIPs.
2. Baseline assessment and improvement: review and assess how the current state of outreach and information dissemination for POPs can be enhanced to help countries and regions comply with their obligations under Stockholm Convention, with a particular focus on innovative and enhanced means of implementation as well as building and enhancing human capacities.
3. Knowledge sharing: Facilitate the sharing of lessons learned, challenges encountered, and good practices in outreach and information dissemination acquired by countries and regional executing agencies throughout the project implementation process.

- Representatives of Regional Centers and relevant stakeholders.
- Stockholm Convention Official Contact Points and National Focal Points, particularly those from project countries.
- Members of NIP National Coordinating Mechanism/ Committees and Project Coordination Units/Thematic Task Groups.
- National officials and experts involved in the process of reviewing and updating the NIPs.
